Carburetors: Everyday Performance LLC ships carburetors USPS Priority Mail to the Continental US. The shipments are insured and delivery confirmation / tracking is included.

Axle assemblies and transmissions: These are shipped within the Continental USA only, via truck freight, strapped to a pallet. Insurance policy is dictated by the freight carrier. Generally, insurance is able to be purchased at additional cost. All freight costs are the responsibility of the buyer.

International shipping: USPS Priority mail international is used for international orders.

Damages in shipping
